SECURITY CAMERAS (CCTV) DISCLOSURE TEXT

This Disclosure Text has been crafted by GÜNSAN Elektrik Malzemeleri Sanayi ve Ticaret A.Ş. ("GÜNSAN") in compliance with Article 10 of Law No. 6698 on the Protection of Personal Data ("Law") and the Guidelines for the Implementation of the Obligation to Inform under the Law on the Protection of Personal Data.

Through the use of security cameras located within and outside our workplace, including office floors, production areas, and the surroundings of the factory, closed-circuit video recording is conducted. This is essential for ensuring the security of our employees, visitors, and the overall building, as well as facilitating the execution of maintenance and repair operations. The recording process is monitored by the Human Resources department for proper management and data transfer.

Data Controller's Identity

The personal data to be processed through security cameras will be preserved and protected under the responsibility of GÜNSAN ELEKTRİK MALZEMELERİ SANAYİ VE TİCARET A.Ş. ("GÜNSAN") as the data controller, in accordance with the provisions of the Communiqué on the Principles and Procedures for the Fulfillment of the Obligation to Inform.

Purpose of Processing Your Personal Data

Your personal data, gathered to fulfill the objectives of maintaining GÜNSAN's building security, is processed through continuous recording 24 hours a day, 7 days a week. This is done to contribute to the safety and protection of GÜNSAN employees, visitors, and assets, as well as to identify and acquire evidence of potential legal violations.

Transfer of Your Personal Data

The mentioned personal data will be shared with judicial authorities and/or relevant law enforcement agencies upon request, as required by applicable legislation, for the resolution of legal disputes.

Method of Collection and Legal Basis for Processing Personal Data

The electronic execution of camera surveillance and recording activities adheres to Law No. 5188 Regarding Private Security Services and its implementing regulation. This is done based on the legal ground of our Company's legitimate interest, ensuring it aligns with the preservation of your privacy rights. Additionally, your personal data is processed as part of our legal obligation to safeguard the safety of employees/trainees and fulfill the responsibilities arising from labor law.

Your Legal Rights:

Your rights are set out in Article 11 of the Law.
